



**MD 586 (Veirs Mill Road)  
Bus Rapid Transit (BRT) Study  
Informational Meeting**



The Montgomery County Department of Transportation (MCDOT), the Maryland State Highway Administration (SHA), and the Maryland Transit Administration (MTA) invite interested persons to attend an Informational Open House introducing a Bus Rapid Transit (BRT) Study on MD 586 from the Rockville Metrorail Station to the Wheaton Metrorail Station in Montgomery County. The purpose of the project is to provide a new high-speed, high-efficiency bus transit service along 6.7 miles of MD 586 to enhance transit connectivity and improve operational efficiency and travel times, while addressing current and future travel demands.

**WHAT:** The Open House will allow the public to provide input on the project Purpose and Need, explain what BRT is and does, and place the current project in the broader context of other county BRT studies. Display areas will be set up and MCDOT, SHA, and MTA representatives will be available to discuss project issues, answer your questions, and record your comments. No formal presentation will be given. You may arrive at any time between 4:30 pm and 8:00 pm and walk through at your own pace.
