- 3 Q Specific to a type of truck that was not a bid item?
A **Please refer to bid items for the specific equipment on pg. 80 ("Description" in the "SCHEDULE OF PRICE")**
- 4 Q Bonding Requirement?
A **No**
- 5 Q Do you have to list every piece of equipment?
A **Yes, that the contractor will be providing**
- 6 Q Can you replace a vehicle that was on the list?
A **Yes, but it must be pre-approved by the Administration prior to it going out on the road.**

- 7 Q Is the contract for a number of pieces of equipment or for maintaining a certain roadway?
A **By the piece of equipment**

- 9 Q How will the State award the contract?
A **By low bid per line item**
- 10 Q Are there MBE goals in the contract?
A **There is no goal in the contract.**

- 12 Q What is the geographic area of the contract? Is it just State roads?
A **See page. 22, "PROJECT DESCRIPTION". Yes, State roads**
