



NOTES:

1. SPECIAL SIGNS MAY BE REQUESTED FROM THE SHA SIGN SHOP. THEY SHOULD BE SPECIFIED BY HEIGHT, TO DETERMINE WHAT BASIC DIMENSIONS ARE UTILIZED, AND LENGTH, IF KNOWN, TO COINCIDE WITH ADDITIONAL PANELS OF THE SAME ASSEMBLY, OR DUE TO RIGHT-OF-WAY CONSTRUCTIONS, ETC. IF LENGTH IS UNKNOWN AND RIGHT-OF-WAY IS CRITICAL, SPECIFY LENGTH AS MAXIMUM AND THE SIGN WILL BE FABRICATED AS SHORT AS POSSIBLE.
2. WHERE APPLICABLE, NAMES SHOULD BE ABBREVIATED TO ACCOMMODATE MESSAGES ON STANDARD LENGTH PANELS.
3. MILEAGE SHALL NOT BE SHOWN ON DESTINATION PANELS.
4. WHEN MULTI-DIRECTIONAL PANELS ARE USED IN THE SAME ASSEMBLY, AS SHOWN, THE STRAIGHT THRU DESTINATION IS PLACED FIRST AT THE TOP, THE LEFT DESTINATION IS SECOND AND THE RIGHT DESTINATION IS PLACED LAST. THERE SHALL BE NO MORE THAN THREE DESTINATION PANELS PER ASSEMBLY.
5. FOR ARROW DIMENSIONS REFER TO ARROWDET-1.
6. FOR VERTICAL ARROWS, VERTICALLY CENTER ARROW ABOUT "B" DIMENSION. DIMENSIONS "F" AND "G" WILL VARY FROM VALUES IN CHART.
